### Making up for Lost Time

#### STILL TIME TO REACH OUT TO THE SENATE SUBCOMMITTEE CONSIDERING FUNDING FOR GVRA - see below

The middle of last week began the mad dash to the 30th day, March 3rd, when all bills must pass out of one chamber to the next. Legislators in both chambers felt the pressure of two winter events on their schedule and even suspended rules to get newly introduced bills into and out of committees in a matter of a few days. There are only three voting days this week and it is expected every day will have a full agenda of bills and resolutions. Thursday will be dedicated as a committee day to finish up any bills still under committee review.

#### **Autism Mandated Coverage**

A great example of a bill that was introduced and passed out of committee in only two days is SB 397 sponsored by Senator Tim Golden (R-Valdosta). For the very first time since the Lt. Governor was elected to his office he came before a Senate Committee in support of <u>SB 397</u>. He said that while he did not support healthcare mandates he felt this measure was necessary to get private insurance to cover treatment for those on the autism spectrum. He stated the successful early intervention for children up to age 6 was more than compelling to place this requirement upon insurance carriers. He explained the State Health Benefit Plan had also taken the step to fund coverage under its healthcare plans and would not be asking the private sector to do

Working Wonders Day March 27, 2014 Noon something state government had not already taken the lead on. Senator Tim Golden expressed similar interests, which is why he took leadership to pull this bill forward quickly. The bill was introduced on February 20th and passed out of the Senate Insurance and Labor Committee that afternoon.

#### Future Revenue in Jeopardy

Sen. David Shafter put forward two resolutions last year to cap tax rates. The proposals, Senate Resolutions 412 and 415, would create two new and separate tax caps in the Georgia Constitution.

<u>SR 412</u> would permanently cap Georgia's sales tax rate, with two exceptions:

- Cities and counties would be free to raise local sales taxes through new SPLOST referendums to fund specific infrastructure projects, like roads and schools.
- State lawmakers would be allowed to raise the sales tax only to reduce the income tax.

<u>SR 415</u> would permanently cap the state's top marginal income tax rate at its current level of 6 percent.

SR 415 is scheduled for a vote on the Senate Floor Monday. You can watch the Floor debate <u>here</u>. While a constitutional amendment does require a 2/3 vote the Senate Republicans have 37 members and this resolution will pass. It is hopeful the House will see the danger these resolutions will have on future legislative authority to make changes to tax rates in times of emergency and hinder tax reform for future generations.

GATES is a member of the <u>2020 Georgia</u> Coalition to seek a balanced budget and revenue solutions that meet the short and long-term needs of the state. 2020 Georgia is opposed to any measures that take away the opportunity to fund community services, healthcare, or education and tie the hands of elected officials in tax reform debates.

#### FY 2015 Budget Progress

The full House voted 169-4 Monday, February 17th, to pass the FY 2015 Amended Budget on to the Senate. Staying true to its said mission of focusing on restoring funds to education, 70% of additional revenue (\$662 million) was directed solely at education. This brings the state budget to \$20.8 billion dollars. The new education funds can be used to restore the instructional calendar closer to 180 days, increase teacher salaries, or cut out furlough days to teachers. The majority of the remaining balance of new revenue went toward merit pay raises for state employees and Medicaid enrollment.

Friday afternoon Senate Appropriations Subcommittee of Human Development and Public Health met to hear from each agency head on the Governor's request for their budgets. The committee did not take public comment nor speculate on any additional funds. Because crossover day is so near and legislators are focused on bills it is unlikely the Senate will take further action on the budget this week. But we do know they will be considering what they can do for their constituents. Location: Sloppy Floyd Bldg
