It's Crunch Time

Last week was a full five days dedicated to legislation in the House and the Senate (update on important bills and issues below). While there was no work in public on the budget there was rumor that the differences in the FY 2011 Amended Budget were so small they did not require a conference committee. So the budget committees were silent all week. The regular committees and the floor of both chambers were busy with hearings and passage of bills to get them moving so they could make it to the other chamber before crossover day. Crossover is set at the 30th voting day of the session and this year currently scheduled for March 16th.

This week there is going to be movement on the FY 2012 Budget by the House because it must get that bill over to the Senate. A House Human Resources Budget Committee has been scheduled for Tuesday, March 8th at 4pm. Then the full House Appropriations Committee is set to meet on Thursday, March 10th at 7:30am in the morning to get the budget on the House floor by the 16th, if not sooner.

Legislative Issues

There are three issues GATES members will be interested in as they are moving through the legislature.

The Comprehensive Revision of the Tax Code is now in bill form. Rep. Mickey Channell (R-Greensboro) with Majority Leader Larry O'Neal (R-Bonaire) as co-sponsor introduced <u>HB 385</u> on Tuesday March 1, 2011 co-signed by top Republican House Leaders. The bill is 127 pages and almost completely mirrors the recommendations of the **Special Council on Tax Reform and Fairness** to reform Georgia's tax code. A special joint committee was appointed to handle the bill and Rep. Channell explained that if the joint committee agrees to a version it will move directly and simultaneously to the House and Senate for floor 9:30 AM Location - TBA

While there was speculation the tax reform bill would not pass this year the reality of a special session to handle redistricting toward the summer and a big election next year makes putting the issue off difficult politically. The Atlanta Journal Constitution published a Special Report on Sunday: Remaking Georgia's Tax Code

(<u>http://www.ajc.com/news/georgia-politics-elections/lawmakers-talk-tradeoffs-861637.html</u>). The major tax changes in the bill include:

Major Tax Reform Components

Casual sales tax - impose sales tax on private sales of airplanes, boats and cars

Cigarette Tax - increase tax from 37 cents to 68 cents on a pack of cigarettes

Grocery Tax - place the 4 percent state sales tax on all groceries **Income Tax reductions** - decrease the top rate of income tax from 6 to 4 percent

Income Tax on Retirees - it eliminates the tax exemptions on certain non-work income such as investments and pension but would not affect Social Security or most disability payments

Service Tax - impose the 4 percent sales tax on services ranging from haircuts to veterinary procedures

Changes in the code impacting non-profit organizations ranging form sales tax to eliminating exemptions is including in the bill. The Special Joint Committee will be able to make changes and there is a range of support for the various proposals in the legislation. We will keep you posted as the committee meets.

On the Expenditure side of the budget equation is <u>SR 20</u>, a constitutional amendment to limit state revenues and expenditures by population and government inflation growth formula. Around the country this type of legislation is commonly referred to as TABOR (Taxpayers Bill of Rights). Basically its goal is to reduce the scope of what government can do, cuts programs and makes it very difficult for new initiatives to occur. The resolution easily passed the Senate by a vote of 42-7 and now awaits consideration in the House Ways & Means Committee.

While immigration may not be of top concern to everyone it is an issue moving quickly through the legislature with lots of support. Last week the House passed **HB 87 - Illegal Immigration Reform and Enforcement Act of 2011** by a vote of 113-56. The bill's goal is to remove undocumented individuals from Georgia and plans to achieve this by targeting businesses. The primary focus of the bill will require all businesses with 5 or more employees to use the federal E-Verify program to confirm a new hires residency status. It also will give police authority to detain suspects and jail them if they think the person is undocumented. For individuals the bill creates a felony offense if a person uses fake identification to obtain employment, punishable up to 15 years in prison. For employees, impacting every employer with 5 or more workers, including non-profit organizations.
