HAPPY NEW YEAR - New People, New Fiscal Year, New Agency

Well, the dust has settled from last Tuesday's primary contests. As expected there were winners and losers. Unexpectedly we have lost two amazing champions

for disability issues in Georgia, Senator Johnny Grant (R-Milledgeville) and Representative Judy Manning (R-Kennesaw). Both legislators had leadership positions in their chambers and always looked at bills in terms of making life better and opportunities more abundant for people with disabilities, their families and those providing services and supports. On a personal note both have been my mentors and they will be missed during the cold, dreary winter months hammering out public policy issues. On the Democratic side Rep. Keith Heard (Athens) lost his primary, a constant fighter for disability services and budget investments.

There were clear Primary victories among **long-term disability champions** who had challengers in their Districts. Here is a breakdown by District by:

Those with NO opposition in the General Election

- Sen. Horacena Tate (D-Atlanta) won 77.17%
- Rep Jay Neal (R-LaFayette) won 56.96%
- Rep Pat Gardner (D-Atlanta) won 62.72%

- Rep Margaret Kaiser (D-Atlanta) won 82.11%
- Rep Pam Stephenson (D-Atlanta) won 81.01%
- Rep Debbie Buckner (D-Junction City) won 55.33%
- Rep. Nikki Randall (D-Macon) won 64.15%

Those with opposition in the General Election

- Sen Ed Harbison (D-Columbus) won 73.40% and has General opposition from Republican Candidate David Brown
- Rep Simone Bell (D-Atlanta) won 58.67% and will have General opposition from Republican Candidate Earl Cooper
- Rep Dar'shun Kendrick (D-Lithonia) won 70.44% and will have General opposition from Republican Candidate C. Tina Hoffer

Because of redistricting we will have many new faces this year and it is critical we get to know them and they get to know the people and services offered by GATES members. There are still run-offs to take place on August 21st. Remember that a few legislators will face a General Election contest. Some of these races may not be settled until November, even though it is unlikely given the tightly packed districts that ensure a Republican or Democratic voting majority. There will be some very tight races this fall. Now is the time to bring all those candidates in to see your programs and visit with your clients.

The Primary voter turnout was 31.48% with the lowest turnout under 20% in Chattahoochee and Liberty counties and the highest over 60% in five rural counties sprinkled throughout the southern part of the state. You can check the status of state and county political races at the Georgia Secretary of State's Office (www.sos.ga.gov) for general information and than click on the link to Election Results.

Money - State Budget Update

The state budget ended FY 2012 with very slow growth. May had a 2.1% revenue increase over May 2011 and June had a 2.6% revenue growth over last year. The state budget only realized 4.8% revenue growth, resulting in \$721.1 million more than the previous year. Georgia collected \$16.05 billion in revenue for FY 2012, still \$3 billion less since the recession began.

We now begin a new budget cycle where State Agencies must submit their budget

recommendations for FY 2013 Amended and FY 2014 to the Governor's Office of Planning and Budget by September 6th. Governor Deal has instructed all agencies, except Education, to cut their budgets 3% in the current year and another 3% for FY 2014 for a total of 6% cuts. The Medicaid and PeachCare budget will have to carve out another 2% for a total of 8% in FY 2014.

This would result in over \$500 million cut to the state budget. It is hopeful the economy will grow and these cuts will not be necessary, but programs will be in jeopardy if budget projections fall short of actual revenue expectations.

Organization - New Agency is born



The NEW Georgia Vocational Rehabilitation Services Agency met for its first official Board meeting on July 24, 2012. The board introduced its members and the new Executive Director Greg Schmieg (photo on left).

Jimmy DeFoor was elected Chair of the Board, Louise Hill Vice Chair, and Marsha Farrow Secretary. They divided the nine-member board into three sets of three-year terms and established a board schedule to meet the second Wednesday of each month at 1pm. Director Schmieg gave an overview of the five programs the agency is responsible to administer and emphasized the goal to serve the consumer. He acknowledged the critical need to work with all the providers and advocacy communities critical to consumer success, specifically mentioning GATES as a key player.

The most illuminating part of the meeting occurred during the budget discussions when Director Schmieg displayed the current budget allocations and his goal to draw down every available federal dollar. The current budget for all programs is \$164 million with \$78,779,078 allocated to the state VR program or 110 Program. The amazing revelation came in the admission that the state has not drawn down the full amount available from the federal 110 Program. Georgia is eligible to draw down \$103 million and has turned back \$27 million in FY 2012 and \$33 million in FY 2011. Director Schmieg asked for everyone to work with him to maximize the request and appropriations for more state

matching funds to draw down Georgia's full allocation.

Having an agency with open board meetings, an open discussion of the budget goals and offer to partner in the advocacy process is quite a change from the past decade. So far this new agency is really stepping up to make VR services in Georgia better.
