#### **Our Message**

Last year the House Human Resources Subcommittee of Appropriations approved \$900,000 to assist training and employment support for Georgians with disabilities in the Georgia Vocational Rehabilitation Agency for the FY 2016 Budget. Please support another \$900,000 for a 1:4 match to total \$4.5 million this year to continue the momentum to fully fund GVRA. We only need another \$4.1 million in state matching funds to fully null down the
